11.	According to the Technical Proposal Scoring Methodology (p.46), the Purchaser favors a commercial off-the-shelf solution that significantly exceeds the requirements described in the RFP. If a certain feature meets the requirements it only gets two (2) points, if it significantly exceeds them – four (4) points. <i>Please confirm if this is true or not?</i>	TD	Purchaser has chosen not to take into account technical factors.
